It is informed with deep regret that **Thiru K.P.Geetha Krishnan, IAS (Retired) (TN:1958) (DOB: 12.11.1935)** formerly Secretary to Government of India, Ministry of Finance, New Delhi passed away this morning (Monday -20/12/2021). The retired deceased officer, retired from service on superannuation on 30<sup>th</sup> November, 1993. It is learnt that the funeral will be held on Tuesday the 21<sup>st</sup> December, 2021 by 10.30 AM at Velankadu Crematorium, New Avadi Road, Chennai.

He was appointed to the Indian Administrative Service on 12.05.1958. He started his career as Sub Collector, Nagapattinam and served as Collector of Salem District. He has held various posts in Government of Tamil Nadu as well in Government of India which includes the Under Secretary to Government, Finance, Joint Secretary to the High Power Committee on Economy & Administrative Re-organization. He was Deputy Secretary/Joint Secretary to Government, Finance Department, Chennai, Deputy Secretary to GOI, M/o. Finance, Deputy Secretary to GOI, D/o Statistics, Cabinet Secretariat, New Delhi, Managing Director (Finance), TIDCO, Commissioner & Secretary to Government, Industries Department, Chairman and MD, SIDCO, Chennai, Joint Secretary / Additional Secretary to GOI, D/o. Expenditure, Additional Secretary to GOI, D/o. Economic Affairs, Ministry of Finance, Secretary to GOI, M/o Environment & Forests. He retired from service on superannuation as Secretary to GOI, M/o Finance on 30<sup>th</sup> November, 1993. He has also held various posts after retirement including Executive Director, International Monetary Fund (IMF) for India, Sri Lanka, Bangladesh and Bhutan from 1993 to 1996 and Chairman, Expenditure Reforms Commission (GOI) from 1999 to 2001. The retired deceased officer was survived by his wife Tmt. Renuka and two daughters Tmt. Madhuca Krishnan and Tmt. Deepa Geetha Krishnan.
