#### ORDER:

In the Government Orders first to third read above, orders have been issued permitting the officers of AIS serving in connection with the affairs of this State to appoint Residential Office Assistant of their choice to assist them to do official work at their residences subject to certain conditions stipulated therein. The consolidated wage of Rs.8000/- per month had been fixed for the Residential Office Assistant appointed by this mode.

2. The Official Committee, 2017 constituted to examine revision of pay and allowances has inter-alia made recommendations regarding revision of the consolidated wage fixed for the Residential Office Assistant appointed by the AIS Officers of their choice to assist them to do official work at their residences.

3. The Government has carefully examined the recommendations of the Official Committee, 2017 and has decided to accept them. They accordingly, order that the consolidated wage fixed for the Residential Office Assistant appointed by the Officers of AIS serving in connection with the affairs of this State, shall be enhanced from the existing rate of Rs.8000/- per month to Rs.12000/- (Rupees Twelve thousand only) per month with effect from 1.10.2017. However, the conditions stipulated in the Government Orders first to third read above shall continue to remain the same.
